- **Registration – 2 parts:** **4H Online Connect** & **Scorechaser** pay entries at shoot \$**150.00**
- **Events:** American Trap (50 bird), American Skeet (50 bird), Whizbang (50 bird)
- **Classes:** Juniors, Intermediate, Senior I, and Senior II
- **Awards:** HOA and HAA awards for each class and Ladies HOA and HAA
1st – 5th place awards for each event. Awards given after all squads finish shooting and after shoot-offs to break any ties.

\$500.00 Scholarship awarded to the Highest Senior II Shooter that is a District 6 4-H member, Proof of enrollment in a college or vocational School required to receive scholarship funding.

- **Concessions:** Food Trucks will be available
- **Deadline:** Both 4H Online entries and Scorechaser entries will close on Thursday July 24th.
- We will have a side game and a 50/50 drawing.

Range Rules

- All shooters must have signed a waiver form upon arrival to our range.
- Transport your firearm: Unloaded, with the action open, with the muzzle always pointed in a safe direction.
- Only the shooters for the current round and designated Range Officials are allowed on the firing line.
- When on the firing line: No smoking, all shooters must wear eye and ear protection, keep your muzzle always pointed downrange.
- Load your firearm only when you are on station and only when it is your turn to shoot. For Trap and 5-Stand, you may place a shell on the carrier or in the chamber with action open, when it is the turn of the shooter immediately ahead of you.
- Absolutely no more than 2 shells loaded at a time.
- Only loads of 1-1/8 oz. or less and shot sizes 7-1/2 to 9 are allowed for any event. Texas 4-H Shooting sports rules apply to all shooting events.
- This is a live-fire range, not a playground...children must always be under the supervision of an adult.
- Alcohol and firearms never mix. No alcohol permitted on Andrews County 4-H shooting range property.
- If you observe anyone engaged in an unsafe activity while on our range, please do not hesitate to call out “cease fire” and immediately notify a range official. We need everyone’s help to keep everyone safe.
- Welcome spectators. We hope you enjoy watching your friends and family shoot. Please stay at least 10 yards behind all firing lines.

WAIVER, RELEASE OF LIABILITY, INDEMNIFICATION & ASSUMPTION OF RISK MANAGEMENT

In consideration of being permitted to enter onto the premises known as the Andrews County Shooting Range located in Andrews County, Texas, and to participate in and/or observe a shooting sports event at the above named facility, the undersigned, individually and/or in his/her capacity as parent/guardian/legal custodian for his/her minor child(ren) identified herein, for himself/herself, his/her spouse, his/her child(ren), his/her guests, legal representatives, heirs and assigns **HEREBY WAIVES, RELEASES AND FOREVER DISCHARGES** the Andrews County Shooting Sports Association, the State of Texas, Andrews County, the City of Andrews and their political subdivisions, and such parties' officers, directors, shareholders, committee members, employees and each of them, together with any corporate and/or charitable entity sponsoring an event, its officers, directors and employees from **ALL LIABILITY** to the undersigned releaser, his/her spouse, his/her child(ren), his/her guests, legal representatives, heirs and assigns, of and from any and every claim, demand, action of whatever kind or nature, either in law or in equity, arising from or by reason of loss, bodily injury or personal injuries known or unknown, death or property damage or damage of any kind resulting; or to result from an incident or accident that may occur from his/her presence or participation, or his/her child(ren)'s presence or participation in a shooting sports event at the Andrews County Shooting Range or any activities in connection with same, and whether by any such parties' negligence or not.

The undersigned understands and acknowledges that shooting sports involve the discharge of firearms or archery equipment and that there are many hazards and dangers associated with the observation and participation in shooting sports activities. Further, the undersigned understands and acknowledges that the above-mentioned entities, their employees and officials, or otherwise, make no representation or warranties, express or implied, as to the safety training or shooting knowledge of safe firearms or archery practices of any of the participants at any event. Therefore, the undersigned assumes full responsibility for the risk of bodily injury, death, personal property damage or other loss of any kind to himself/herself, his/her spouse, his/her child(ren), his/her guests that may occur during or as a result of the observation or participation in a shooting sports event, whether such risks are foreseen or unforeseen and whether or not the same is caused by negligence of any of the above-mentioned entities, their employees and officials, or otherwise.

The undersigned further agrees to indemnify all of the above-mentioned entities, their officers, directors, shareholders, committee members, employees and each of them, from any loss, damage or cost they may incur due to the undersigned's, or the undersigned's minor child(ren)'s observation or participation in a shooting sports event.

This **WAIVER, RELEASE OF LIABILITY, INDEMNIFICATION & ASSUMPTION OF RISK** is intended to be as broad and inclusive as permitted by the laws of the State of Texas, and if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. The undersigned further states that he/she has carefully read this document and knows the contents thereof and has signed this document as his/her own free act.

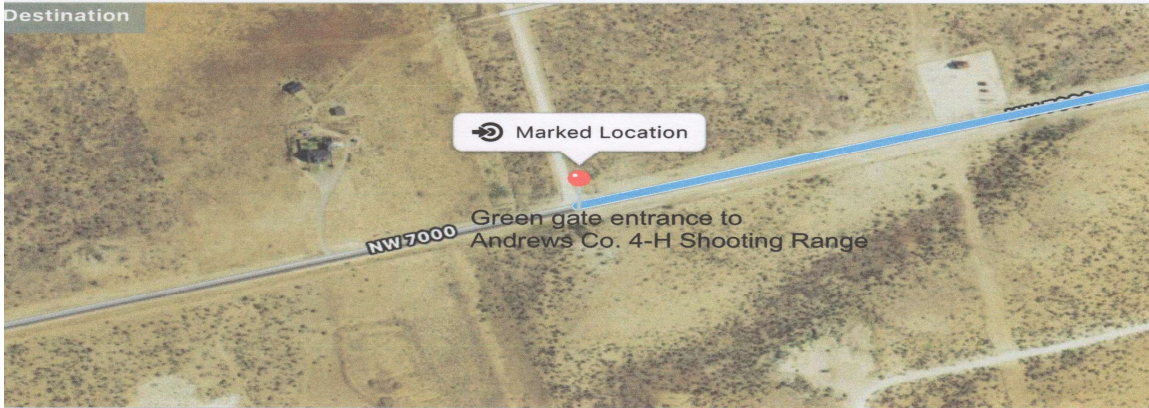
